You are asked to complete this form as part of the Prekindergarten registration application procedure.

Please read the following guidelines and procedures and sign below.

1. Student registration information and immunization requirements for my child will be presented/met by the first day of school attendance.
2. It is my responsibility to transport my child to and from school.
3. All payments are to be made in person (cash or check) or online using www.mypaymentsplus.com. We do not accept mailed checks.
4. The school district must be notified in writing a minimum of two weeks prior to withdrawing my child. If you wish to return, you will be required to continue payments on time each month.
5. I will address any concerns regarding behavior management with my child at school with the appropriate school staff members. *(I also understand that if students have persistent behavior problems that interfere with the general welfare of others, they may be temporarily or permanently removed from the program.)*
6. Frisco ISD Early Childhood School follows the Frisco ISD school calendar. Prekindergarten students are expected to adhere to the Frisco ISD school attendance policy.
7. I agree to pay the yearly fee in nine installments, with the first installment due **by September 1st** and the remaining installments due the first school day of each month.
8. When payments are delinquent more than the 10th day of the month, a student may be dropped from the program without notification.
9. Picking up my child promptly at the end of the school day is a requirement.
10. I understand that if I notify the campus two weeks in advance of leaving the program my tuition will be prorated to the half month.

By enrolling my child in the tuition-supported Early Childhood Prekindergarten Program, I agree to the above statements about procedures and guidelines.
