Vendor Rules and Regulations**

1. Refunds will not be issued
2. An exhibitor will be considered a NO SHOW if he or she has not arrived by 7:00 am on Nov. 6, 2010. At that time the booth space may be released for resale.
3. Set-up must be completed between 6:00-8:45 a.m. on Saturday, November 6, 2010. Takedown must be completed by 6 pm that same day.
4. If a booth space is empty, it cannot be retained by another exhibitor without permission from a Stars Booster Club official.
5. Vehicles may not be parked in the fire lane after loading and unloading supplies.
6. Nails or anything that will mark the walls or floors of the school may not be used. Tape is acceptable.
7. The Stars Booster Club officials shall designate selling areas and each exhibitor shall sell and display within the confines of his/her designated area only.
8. The Stars Booster Club officials and Frisco Independent School District reserves the right to restrict the sale, display, or distribution of any printed materials, photographs, books, magazines, pictures, paraphernalia, or other representations in order to maintain a proper, moral, wholesome environment.
9. Exhibitors shall not bring upon or distribute on the grounds of Frisco High School any political, religious, solicitation materials or handbills without the consent of the officials.
10. Booth spaces cannot be used for games of skill, raffles, lotteries, palm readings or such actions for any purpose related to carnivals.
11. The following will not be allowed for any reason: alcoholic beverages, amplifiers, sale of prepared food such as bake sale items.
12. The Frisco ISD, its employees, the Stars Booster Club and its officials, Frisco HS, and the Stars Drill Team will not assume responsibility or be held liable in the event of personal injury, accident, damage or theft of merchandise.
13. Any returned checks will incur a fee in the amount of \$30.00.
14. We strongly encourage exhibitors not to close their booths before 4:00 p.m. on Saturday, November 6, 2010.
