

Liberty High School Off Campus Transportation 2011-2012

You have signed up for a class that will be taught at Centennial or Heritage High School. Taking courses at these campuses is a privilege and should be treated as such.

The following rules are in place for your safety regarding transportation:

- 1) **FIRST** period at CSH or HHS? You have two options:
 - a. Provide your own transportation to CSH/HHS in the morning, then either ride the bus back to LHS or drive yourself back to campus ***
 - b. Ride the bus from LSH each morning and ride the bus back to the LHS campus following class. **The bus will leave LHS at 8:30 AM from the BACK of the building.**

- 2) **SECOND OR THIRD** period at CHS/HHS? You **MUST** ride the bus to the campus then ride the bus back to LHS following class.
 - a. The bus for **second** period leaves the **FRONT** of the building at 10:35 AM
 - b. The bus for **third** period leaves the **FRONT** of the building at 12:45 PM.
(You will eat during A lunch on those days).

- 3) **FOURTH** period at CHS/HHS? You have two options:
 - a. Provide your own transportation to CHS/HHS ***
 - b. Ride the bus from LHS. Bus leaves from **FRONT** of the building at 2:45 PM.
 - c. **If you need bus transportation home from CHS or HHS, please see Mr. Warstler TODAY!**

*** In order to drive yourself or to ride with another student you must complete the "Off-Campus Permission Form" and return to Cathy Hoffmeister in A110 **PRIOR** to driving to another campus. Each student must also have a current campus parking permit on file with LHS.
