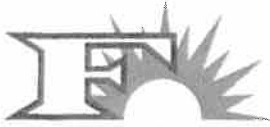


## First Time Enrollment and Kindergarten Round-Up

*Dear Parent,*

Your child's school, along with the FISD Communications Department, tries very hard to let the community know about all the wonderful things our students and teachers are doing. In order to send your child's picture or name to the newspapers or post it on our web site or cable channel, we must have your written permission. On the attached form you will see release information for allowing us to publish your child's photo, name, grade, and any awards or honors he or she receives.

If the student is on a school team, we may release the student's weight and height, and for some awards we may report dates of attendance, and the last school they attended. (*Such as they have attended Frisco schools since 7th grade and came to us from Plano ISD.*) We regularly submit articles to area media outlets.

**We will not release your address, phone number or email address as directory information. It is not released to anyone other than for school purposes.** If booster clubs or PTA's want to do an address, telephone, or email directory, they must receive your written permission to do so.

On this attached form, we ask that you **Check Yes** under **Release of Directory Information for School-Sponsored Purposes** so we can release your child's name, photo or video for school publicity purposes such as the yearbook, recognition of activities, the district or campus website, and releases to local media.

If you do not want your child's information released for school-sponsored purposes, such as the yearbook or articles about honors your child receives, you must check No under the Release of Directory Information for School-Sponsored Purposes and return this within 10 days of receiving this notice.

Because federal law requires districts to provide the military or colleges, student information upon request – **parents who do not want their high school student's information disclosed to military recruiters must check the square in the shaded section at the bottom of the form.**

Thank you for taking the time to fill out the Student Directory Form and for allowing us to tell the world about our wonderful students in FISD. *The privacy and disclosure elections submitted on this form will remain in effect for your student until such time as you submit a new form indicating a change in your privacy and disclosure preferences. ## Student Directory Information Legislative Update [Sec. 26.013]

*Office Note - Keep document in Cumulative Folder*

Frisco ISD provides notice to the parent of each district student at the beginning of each school year or on enrollment of the student after the beginning of a school year in the student handbook the following information: (1) a written explanation of the provisions of the Family Educational Rights and Privacy Act of 1874(20 U.S.C. Sec.1232g), regarding the release of directory information about the student and (2) written notice of the right of the parent to object to the release of directory information about the student under the Family Educational Rights and Privacy act of 1974 (20U.S.C. Sec. 1232g).

*The privacy and disclosure elections submitted on this form will remain in effect for your student until such time as you submit a new form indicating a change in your privacy and disclosure preferences. Please note that a change can be submitted at any time, including at the beginning of each school year, or at any time during the school year.*

### NOTICE

Certain information about district students is considered directory information and will be released in order to promote school programs and student achievement, unless the parent or guardian objects to the release of the directory information about the student. If you do not want Frisco ISD to disclose directory information from your child's education records for the purposes identified herein without your prior written consent, you must notify the district in writing by the end of the first 10 days of instruction.

Frisco ISD has designated the following information as directory information:

*Student's name, photograph, honors and awards received, date and place of birth, participation in officially recognized activities and sports, weight and height of members of athletic teams, dates of attendance, enrollment status and most recent educational institution attended.*

*Note: FISD DOES NOT designate address, phone number or e-mail address to be directory information.*

### Release of Directory Information for School-Sponsored Purposes

**YES**, my student's directory information can be released **ONLY** for the following limited school-sponsored purposes: student recognition activities, yearbook or student newspaper, printed programs for extracurricular activities, news releases to local media, district/campus and education related websites, district/campus and education related video and audio (such as podcasts), district/campus and education related publications, FISD cable access channel, etc.

**NO**, I do not want **ANY** of the directory information released, even for limited school-sponsored purposes such as: student recognition activities, yearbook or student newspaper, printed programs for extracurricular activities, news releases to local media, district/campus and education related websites, district/campus and education related video and audio (such as podcasts), district/campus and education related publications, FISD cable access channel, etc. I understand that this means my student will not be included in positive publicity about his/her achievements, and will **NOT** be included in the yearbook and other such publications.

**Failure to Respond** – In the case that parents fail to check "yes" or "no" or fail to return this form, the District will assume the parents consent for release of the students' directory information to be released **ONLY** for limited school-sponsored purposes. Directory information for limited school-sponsored purposes remains otherwise confidential and will not be released to the public without the consent of the parent or eligible student.

**Secondary Students Only** [Federal Law requires districts receiving assistance under the Elem. And Sec. Education Act of 1965 (20 U.S.C. Section 6301 etseq.) to provide a military recruiter or an institution of higher education, on request, with the name, address, and telephone number of a secondary student unless the parent has advised the district that the parent does not want the student's information disclosed without the parent's prior written consent.]

**DO NOT RELEASE** my child's name, address and telephone number to military recruiters.
