Revised Quarantine Period and Updated Case Data



Quarantine for Close Contact

CDC GUIDANCE

The CDC continues to recommend a 14 day quarantine for those who have come into close contact with a positive case.

CLOSE CONTACT

Within 6 feet of a positive case for a total of approximately 15 minutes throughout the course of the day if either the infected person or the contact are not properly masked.

QUARANTINE OPTIONS

CDC has provided two additional options for local health authorities to consider when quarantining.

FRISCO ISD PROTOCOL

Close contacts are now required to quarantine for 10 full days prior to returning. A test is strongly recommended, but not required.




7-DAY WITH NEGATIVE TEST

Approximately 5% risk of transmission which is about 44 people over the course of a week

10-DAY WITH NO TEST

Approximately 1% risk of transmission which is about 9 people over the course of a week



3 PEOPLE PER WEEK

AFTER 10 DAYS WITH PCR TEST



PRIOR TO HALLOWEEN

7-Day average daily
new cases were
stable at about 10 for
most of October

HALLOWEEN SPIKE

In the first 8 days of November, average new cases increased from 10 to 26

CURVE FLATTENING

From Nov 8 to Nov
27, average daily new
cases decreased to
17.

THANKSGIVING SPIKE

4 of the 5 highest
daily case numbers
came from 4-7 days
after Thanksgiving
spiking average new
cases to 33

AFTER THANKSGIVING


New cases are stabilizing, but remain at the levels seen during the Halloween spike

New Staff Cases






EFFECTIVE MITIGATION

3,843 students and staff have completed quarantine for close contact on campus. 1.1% of those have tested positive with no known external exposure. By contrast, 2.1% of the population of Frisco ISD student and staff have tested positive and about 3% of the population of Collin and Denton counties have tested positive


DAILY CASES PER CAMPUS

CLOSE CONTACT REVIEWS

SOPHISTICATED CASE INVESTIGATION

Since school started, campus CCRTs have responded to 1,511 positive cases. They have identified 4,435 close contacts. They have monitored 3,183 people with symptoms. These teams made up of campus administrators and guided primarily by 91 nursing personnel across the district have managed the most severe and widespread public health emergency in over a century in a way that has made Frisco ISD schools one of the safest places to be.
