The Child Nutrition Department participates in The USDA National School Lunch and School Breakfast Program. Participation in these programs requires compliance with specific menu guidelines based on the 2010 Healthy Hunger Free Kids Act. At each meal service, students are offered a variety of fruits and vegetables, whole grain rich options, quality protein, and low-fat plain milk or fat free flavored milk. Meals must include a fruit or a vegetable to receive meal prices. When students purchase food items outside of a meal or not enough to count as a meal, they will be charged a la carte prices.
