Vision

The vision of the Frisco ISD Parent and Family Engagement Program is to effectively engage all families through equitable and innovative practices to ensure student success.

Mission

The mission of the Frisco ISD Parent and Family Engagement Program is to link parents to learning through authentic connection and engaging education.

Statement of Purpose

Frisco ISD is dedicated to providing a quality education for every student in our district. To accomplish this objective, the district develops and maintains partnerships with parents and families in all aspects of the various local, state, and federal programs offered in Frisco schools. The district believes that establishing and maintaining open lines of communication expands and enhances learning opportunities and creates the best learning environment for every child.

Parent and Family Engagement Policies

The district must have a Parent and Family Engagement Plan to support Pre-K and Title I campuses. This policy details how the district or campus will effectively engage parents in their students' learning. The policy must be jointly developed with parents. The policy should be updated annually based on meaningful feedback provided by parents of participating students. The policy should be distributed to all families annually.

School-Parent Compacts

In accordance with Title I regulations, each Frisco ISD Title I campus has developed and will update a School-Parent Compact annually. Title I Parent Advisory Council

The Frisco ISD Title I Parent Advisory Council comprises parents, district leaders, and school principals. This team discusses the design and implementation of the Parent and Family Engagement Policy. In addition, the team involves parents in developing and improving various aspects of the District Title I program.

Annual Meeting for the Title I Parents and Families

Frisco ISD uses Title I funds to provide services for all students at our designated Title I campuses. Title I campuses hold at least two meetings annually to review Title I guidelines and services offered through this programming. The annual meetings are held at different times and on different days to accommodate parent and family schedules. Notifications of the meetings are provided to parents and families through flyers, email, and other public announcements and notices. Translators are available to help with Non-English speaking parents and families upon request.

The Parent and Family Engagement Policy and the Parent-Student Compact for each campus are reviewed at those meetings. Parents and families are encouraged to become involved in revising and updating the policy by participating in Campus Improvement Teams (CIT).

Parent and Family Engagement Opportunities

Frisco ISD encourages parent and family engagement in a variety of ways as it strives to develop and maintain an optimum learning environment for all students. Parents and families may:

Building Capacity

Building capacity is the process of developing and strengthening the skills, abilities, processes, and resources of organizations and communities to help them adapt, survive, and thrive in a changing world. Frisco ISD values the partnership of parents in their children's education. Student achievement is the result of effective home-school-community partnerships. Parents and families can contribute to their student's success in many ways, both at home and through volunteering at the school. The district provides multiple methods for building the capacity of parents and families to support their children's education:

- Assist parents and families in understanding state academic content standards and academic achievement standards, local academic assessments, how to monitor a child's progress, and how to work with educators to improve student achievement
- Provide materials and training as necessary to help parents and families work with their children to improve achievement
- Provide education to teachers, principals, and other staff on ways to reach out to, communicate with, and work with parents and families as equal partners.
- Provide parent and family engagement programs with preschool programs
- Provide a parent resource center at the Early Childhood School that can be accessed by all Frisco ISD parents and families
- Provide information to parents and families in an understandable language as needed

Staff and Parent and Family Communication

Parents and families are informed of school activities throughout the school year through various forms of communication. Newsletters, teacher notes, the school marquee, conferences, personal contacts, phone calls, websites, emails, written notices, coffee talks, and social media are used to establish and maintain open lines of communication with parents and families.

Interpretation and Translation Guidelines

Frisco ISD has a diverse multicultural population speaking a variety of languages. Frisco ISD provides interpretation and translation services to support our multilingual students and families. The top 10 languages of students and families we serve are as follows: Spanish, Telugu, Tamil, Korean, Arabic, Hindi, Urdu, Mandarin, Japanese, and Portuguese. Translators are provided for parents, and information is provided in an understandable language as needed.

Frisco ISD has partnered with Language Line Solutions to assist staff at schools and district facilities. Secretaries at campuses and front desk staff at the administration building have access to interpreters in more than 240 languages. Campus secretaries may share Language Line campus codes with any personnel in the building who need translation services to communicate with a student or family. The services with Language Line include interpretation services via phone and the Language Line app, which also includes video interpretation services in over 40 languages. The services with Language Line Solutions can be utilized for scheduled meetings, unscheduled visitor assistance, and during phone calls with families. Frisco ISD additionally provides interpretation at meetings including ARDs through approved vendors.

At all Title I campuses, the Parent & Family Engagement (PFE) Policy and the School-Parent Compact are translated into Spanish. Additionally, at any Title I campus, if the eSchool field for home language among the entire student population is

greater than 25% for any one language, the campus must translate the Parent & Family Engagement (PFE) Policy and School-Parent Compact into that language. Please contact the Federal Programs Department for assistance with translation if needed.

Coordination of Programs

Parents and families will be consulted in designing, developing, and implementing the Title I Program at designated Title I campuses. Parents and families will also be invited to participate in workshops addressing areas of growth as identified in the campus improvement plan.

At the beginning of each year, teachers provide parents and families access to the learning goals and objectives that students will be expected to work toward and master. Frisco ISD recognizes that some students will need modifications, accommodations, or extra assistance to maximize student achievement. These will be provided to students through the Title I Program and educational services offered through the district.
