



Frisco ISD Purchasing Department Handbook

The Purchasing Department builds vendor relationships to buy goods and services for FISD in compliance with state and federal laws and local policies and procedures. We are responsible for district-wide procurement for education, research, and business initiatives.

Purchasing's handbook outlines standard procedures for staff managing the "purchase to pay process" (see also [TEA's Financial Accountability System Resource Guide \(FASRG\)](#), [EDGAR](#), and [The Administrator's Reference Manual \(TDA ARM\)](#), & [Board policies](#)). It ensures are consistent and follow all applicable regulations. The manual is updated biennially to reflect changes in practices and legislative or policy updates.

The handbook includes:

- Standards of conduct, including ethics and conflicts of interest
- Purchasing goals and objectives
- Relevant statutes, regulations, and board policies
- Purchasing authorities
- The purchase to pay process (requisitions, POs, change orders)
- Contract management
- Receiving requirements
- Bid and proposal forms
- Guidance on minor (e.g., low dollar, quotes, spot purchases) and major (e.g., high dollar and/or complex) purchases

Annual Ethics Statement

Purchasing staff review and acknowledge ethical standards annually, integrating them into all FISD purchasing functions. We foster strong vendor relationships, promoting open competition, and ensuring impartiality in procurement.

Purchasing communicates ethical standards regarding conflicts of interest, financial interests in vendor firms, and the acceptance of gifts to district staff, as needed. We understand the penalties for violating purchasing laws, including criminal prosecution and job loss. ***Staff must be familiar with FISD Board policies on conflicts of interest and ethics.***

Common standards of ethics (from FASRG 5.2). Common ethical standards for purchasing department staff are as follows:

- It is a breach of ethics to attempt to realize personal gain through public employment with a school district by any conduct inconsistent with the proper discharge of the employee's duties.
- It is a breach of ethics to attempt to influence any public employee of a school district to breach the standards of ethical conduct set forth in this code.



- It is a breach of ethics for any employee of a school district to participate directly or indirectly in a procurement when the employee knows that:
 - the employee or any member of the employee's immediate family has a financial interest pertaining to the procurement.
 - a business or organization in which the employee, or any member of the employee's immediate family, has a financial interest pertaining to the procurement; or
 - any other person, business, or organization with whom the employee or any member of the employee's immediate family is negotiating or has an arrangement concerning prospective employment is involved in the procurement.
- It is unethical for any employee or former employee of a school district to offer, give, solicit, demand, accept, or agree to accept any gratuity or employment offer in connection with decisions, approvals, recommendations, program requirements, procurement, specifications, advice, investigations, audits, or any other matter related to contracts, subcontracts, or pending solicitations.

Acceptance of gratuities may be construed as a criminal offense.

- It is a breach of ethics for any payment, gratuity, or offer of employment to be made by or on behalf of a subcontractor under a contract to the prime contractor or higher tier subcontractor for any contract of a school district, or any person associated therewith, as an inducement for the award of a subcontract or order.
- The prohibition against gratuities and kickbacks prescribed above should be conspicuously set forth in every contract and solicitation, therefore.
- It is a breach of ethics for any employee or former employee of a school district knowingly to use confidential information for actual or anticipated personal gain, or for the actual or anticipated gain of any person.

- I will not participate if I am currently employed by or compensated by any vendor

- I will act independently and without external pressure in all procurement processes
- I will not accept gifts, loans, or favors in exchange for favorable consideration

Fair Treatment and Confidentiality.

- I will remain impartial and treat all potential vendors equally
- I will ensure specifications and evaluations are unbiased
- I will maintain procurement information confidentiality
- I will only share information with authorized FISD staff following proper procedures

Laws, Policies, Procedures & Violations

State law imposes criminal penalties for violations of purchasing requirements, as outlined in the [Texas Education Code \(TEC\) §44.032](#) and the [Texas Local Government Code §271.029](#). The Texas Penal Code, Chapter 36, addresses corrupt influence violations. A public servant commits an offense if they solicit or accept benefits related to contracts or transactions they oversee. Offering a benefit to a public servant that is prohibited by law constitutes a Class A misdemeanor.




FIGURE 1: Federal and State Laws and Local Purchasing Policies and Procedures

Procedures, Manuals, Guidance & Training Materials. The following training guides and manuals govern the activities of the Department:

Frisco ISD's [Child Nutrition Purchasing Procedures](#) are included by reference. If any local procedure manuals or training materials conflict with FISD Board policy, the Board policy takes precedence. If the training materials or procedures do not address a purchasing or contracting procedure, then Board policy and applicable state and federal laws apply.

Board of Trustee Policy. The policies listed below pertain specifically to Purchasing. The complete [FISD Board of Trustee](#) policy book is available on the FISD website. LEGAL policies encompass federal and state laws and court decisions, providing statutory context for all other policies. LOCAL policies reflect decisions made by Trustees. If any Board policy conflicts with state or federal law, the law prevails. If the Board policy is silent on a topic, state and federal law should guide the purchasing decisions.

The following *State of Texas Laws* govern purchasing and contracting activities for school districts. Federal law takes precedence over state law in case of conflicts. When state law is silent on purchasing or contracting, federal law applies.

[Texas Administrative Code \(TAC\) 109.41](#): Adopts the Financial Accountability System Resource Guide (FASRG), which mandates rules for Texas public and charter schools.

[Texas Education Code \(TEC\) Title 2 Chapter 44 Subchapter A](#): Covers school finance and fiscal management for school districts.

[Texas Government Code \(TGC\) Title 7 Chapter 791 Subchapter A](#) (interlocal agreements); [Title 10 Subtitle F Chapter 2254 Subchapter A](#) (professional and consulting services); [Title 10 Subtitle D Chapter 2155 Subchapter A](#) (general purchasing rules and procedure); [Title 10 Chapter 2157 Subchapter A](#) (automated information systems); [Title 10 Subtitle F Chapter 2269](#) (contracting and delivery procedures for construction projects).

[Texas Local Government Code \(TLC\): Chapters 171, 176, and 271](#) address conflicts of interest, disclosure of relationships with local government officers, public access to information, and purchasing authorities of local entities.

[Texas Penal Code Chapter 36](#): Addresses bribery and corrupt influence.

Annual Aggregating of Expenditures

“Aggregate” in TEC §44.031(a) is the total expenditures for similar goods and services that would typically be purchased together over a 12-month period (July 1 to June 30).

Commodity Codes & General Ledger. Frisco ISD utilizes United Nations Standard Products and Services Codes (UNSPSC) to categorize purchases. We review general ledger (GL) data to



make informed decisions about purchase methods, as well.

Annual Review for Planning Purposes. The department analyzes a full fiscal year’s expenditures (commodity codes and GL) to plan small purchases (under the simplified acquisition threshold) and formal solicitations for the upcoming year (TEC §44.031).

Periodic Review. Purchasing conducts quarterly reviews of purchase data to ensure spending in any category does not exceed \$50,000 unexpectedly and we are consistent with our activities based on our annual aggregating.

When a requisition is submitted for an “under \$50K” purchase, the vendor team reviews expenditures and commodity codes. If total spending in a category is under \$50,000, the requisition is processed. If it exceeds \$50,000, the vendor team must find an appropriate purchasing method. The review of aggregate expenditures is documented in eFin. If necessary, the vendor team will notify the bidding team to prepare a formal competitive bid.

An “under \$50K” approval is temporary. Vendors are encouraged to respond to FISD solicitations to maintain their access to FISD as “customers”.

Competitive Bidding for Purchases of \$50,000 or More

District purchases of goods and services valued at \$50,000 or more over a 12-month period must be the best value to FISD (TEC §44.031(a)). This does not apply purchasing produce or vehicle fuel. (Contracts and POs are legal commitments on behalf of Frisco ISD).

Purchases expected to exceed \$50,000 in a fiscal year must be bid or obtained through a purchasing cooperative that complies with the state and federal laws applicable to FISD. Purchasing is responsible for ensuring compliance with bid laws and district purchasing procedures. We also develop procedures to promote full competition among vendors, as competition is generally legally required.

The table below lists allowable purchase methods for purchases of over \$50,000 (formal).

Quotes (Informal) Bidding (Under \$50K Spend)

Frisco ISD self-certifies purchases under \$50,000 to TEA. On TEA guidance, we have internal requirements complying to all regulations for these purchases (TABLE 3). For questions about the self-certification process, please contact Compliance.

Federal agencies, including the Department of ED, require districts receiving federal funds to have set of purchasing policies, regardless of the funding source—federal, state, or local. All purchases must adhere to the same quote rules as those for federal funds.

Review of Required Quotes. Quotes must be attached to requisitions processed in e-Fin. Purchasing reviews attachments to ensure the appropriate number of quotes are included and, if necessary, a best value form is attached (see **Attachment 2** for requisition review information).

Additional Considerations.

- **Quote help.** Staff can request help with quotes using the Purchasing Help tile in the staff portal.
- **Competitive FISD Bids.** A purchase from a vendor on a competitive RFP satisfies quote requirements: no additional quote is needed. (this is an RFPs on which one vendor was awarded).
- **Catalog and other RFPs with multiple vendor awards.** If a purchase is made from a vendor on a catalog or Multiple Service Award (MSA) RFP, quotes must be provided.
- **EDGAR-Compliant Cooperatives.** For a purchase from a vendor on an EDGAR-compliant purchasing cooperative, end users must still gather quotes to comply with Frisco ISD policies.
- **Purchases Under \$50,000.** For purchases under \$50,000 from vendors not on a FISD bid or part of a purchasing co-op, quoting requirements must be met. The vendor team reviews the District's aggregate spending on defined categories goods & services for “under \$50K” purchases.

Contracts of \$100,000 or more must be approved by the FISD Board of Trustees. Purchasing may request additional quotes or information from FISD staff (due diligence) for large purchases requiring Trustee approval.

Non-Competitive Purchases

Certain purchases are non-competitive according to [FASRG, Module V, Section 5.10](#). A non-competitive purchase is not the same as a sole source purchase. For goods or services available from only one vendor, follow the procedures for approving sole source vendors.

Generally, non-competitive purchases under [FASRG 5.10](#) are limited to less than \$50,000 in total over a 12-month period. If FISD plans to spend \$50,000 or more with one vendor, or if total expenditures for the year will reach \$50,000, additional review is required. The following purchases are classified as non-competitive ([FASRG 5.10, pgs. 27-29](#)):

- Services from a unit of state or local government
- Memberships in professional organizations
- Assemblies, seminars, and workshops



- Conferences
- Subscriptions
- Field trips
- Venues for student and extracurricular events

Key categories include:

- Governmental entity: Services only available through a governmental entity. If total costs exceed \$50,000 annually, a formal interlocal agreement is needed.
- Professional organization: Membership or registration fees. If total annual payments exceed \$50,000, a justification letter may be required.
- Assemblies, seminars, workshops: Events hosted by non-FISD individuals with fees. If total costs exceed \$50,000 annually, TEC §44.031 applies. FISD permits limited purchases of materials related to these events, as well as for direct instruction materials to implement learned strategies.

Sole Source Purchases. Sole source purchases are non-competitive procurements allowing a single supplier to provide products or services to FISD, exempt from competitive procurement requirements under TEC 44.031. *(See Sole Source Purchase Approvals section below).*

TEA defines a sole source as a vendor providing:

- An item restricted by patent, copyright, secret process, or monopoly
- A film or manuscript
- Utility services
- Captive replacement parts for equipment

While patents or copyrights are factors, the primary consideration is whether there are no other products or services serving the same purpose available. Some vendors—especially those offering software, subscriptions, and professional development—claim sole source status, often because they tailor their products to FISD. However, this does not automatically qualify them as sole source under the legal definition. Purchasing regularly reviews sole source vendors to make sure the vendor is still a sole source and encourages vendors to register in Ion Wave for RFP opportunities they should respond to if they wish to continue having FISD as a customer.

Sole Source Procedure and Approvals. FISD adheres to EDGAR guidelines for sole source purchases. Sole source justifications include:

1. Items protected by patent or copyright.
2. Films or manuscripts or theatrical royalties
3. Utility services.
4. Captive replacement parts.

Sole source exceptions are limited, and alternatives should be sought for vendors claiming sole source status. For federal funds, affidavits are not accepted.




Approvals. For sole source vendor requests:

1. Buyers receive requests for purchases from vendors claiming sole source status.
2. Verify if the vendor is registered in E-Fin. If not, follow TEC §44.031 requirements.
3. Collaborate with the Vendor Team for vetting.
4. The Vendor Team checks for alternative procurement methods.
5. If necessary, conduct informal bidding through Buyboard or IonWave.
6. Document findings in a purchase justification, which must accompany requisitions.
7. Track sole source vendors and update records accordingly.
8. Send template response emails on official Fisd letterhead to notify vendors of their status and guide them on registering in IonWave.

Interlocal Agreements. An interlocal agreement is formed when one local government contracts with another to provide goods and/or services. FISD has interlocal agreements with several entities, including the Educational Purchasing Cooperative of North Texas and the Central Texas Purchasing Authority. These agreements allow for shared contracts, enabling FISD to utilize bids awarded to other ISDs. For a complete list of ISDs whose contracts FISD can use, please contact robersonj@friscoisd.org.

Competition in Cooperative Purchases. Purchases through an EDGAR-compliant cooperative generally meet competitive bidding laws. However, quotes are required according to TABLE 1. FISD staff will additional quotes them in certain cases, such as:

- Purchases of \$100,000 or more
- New products or services not previously used by FISD
- Critical, high-priority projects
- To meet guarantor requirement.

Professional Services. Professional services, defined in TEC and TGC, are not evaluated solely on price but on the quality of service provided. While there is no formal definition, TEC §44.031 and TGC Chapters 2254 and 2269 specify certain services considered professional. Professions



include, but aren't limited to: Certified public accountants, fiscal agents, financial consultants, and technology consultants, attorneys, real estate appraisers, nursing and medical professionals, landscaping architects, architects, engineers, land surveyors, and construction material engineers, testers, and inspectors.

FISD Bidding

Purchasing coordinates competitive bidding and vendor selection for campuses and administrative offices, managing the entire process for District solicitations. The exceptions to this are FF&E and construction projects, which are handled by the Operations and Construction Departments. This process, termed an FISD bid (see **Attachment 1**) and includes:

- Intake of purchase requests.
- Evaluating the need for informal or formal procurement based on state and federal laws.
- Collaborating with subject matter experts to develop requests for quotes, bids, and proposals.
- Scheduling the solicitation timeline.
- Assisting in preparation of bid documents and specifications.
- Distributing requests for bids to interested vendors.
- Receiving and assessing vendor submissions for responsiveness.
- Analyzing bid documents and preparing qualification recommendations for School Board approval.

Upon qualification, qualified vendors are notified, and District purchase orders are processed.

Proposal Submission. Proposals are preferably submitted online via Ion Wave, a bidding management system. Alternatives include postal service or in-person delivery before the bid closing date. Buyers must monitor mail to include hard copy bids in the RFP process.

Intake and Evaluation of Purchase Methods.

1. Buyers assist FISD staff with procurement-related inquiries.
2. The Buyer identifies:
 - Anticipated purchase value.
 - Availability of current vendors for similar goods/services.
 - Possibility of using an EDGAR-compliant purchasing cooperative.
 - Whether the product is available from a sole source, following appropriate procedures if so.
3. Buyers evaluate intake information to determine the required procurement method.

Developing Solicitation Documents and Schedules.

4. The Buyer creates a bidding schedule and determines the date for Board approval.
5. Using the FISD Bid Work Plan, the Buyer collects necessary information for new bids to include:
 - Required services and products.
 - Technology support.



- Scope limitations.
- Confidential data handling.
- Delivery and invoicing requirements.
- Certification/licensing needs.

The Buyer and staff collaborate to establish evaluation criteria and identify necessary criteria for responsive bids. They also select a minimum of three evaluators and their alternates.

Confidentiality and Guidelines. All participants in the bidding process sign an FISD Non-Disclosure Agreement (NDA) before any documents are released. Signed NDAs are stored in Smart Sheets until bids close after which they are moved to Ion Wave. Evaluators receive FISD Evaluator Guidelines, which must also be signed and returned before the release of vendor bids. These documents follow the same storage protocol as the NDAs

Bid Preparation and Evaluation Process.

6. After receiving the [NDA and Evaluator Guidelines](#), the Buyer adds new evaluator documents to the google drive.
7. The Buyer gathers potential bidder information from campus and department staff, including email addresses for contacting vendors about registering in Ion Wave's supplier portal.
8. The Buyer emails the timeline to staff, including deadlines for:
 - Bid posting
 - Bid acceptance
 - Submission for review
 - Evaluation return dates
9. The Buyer drafts the bid opportunity in Ion Wave, ensuring compliance with template standards, including required items like a conflict of interest questionnaire. The Buyer decides on:
 - Rolling evaluation periods
 - Auto-renewal options
 - Multiple Service Award (MSA) or Catalog bids, notifying the Director as needed for memo justification.
10. A draft bid is sent to campus or department staff for review and written approval before issuance. This can also be done through a meeting, followed by an email confirmation.
11. All communication regarding open solicitations must go through Purchasing; staff should not discuss these with potential vendors.

Distribution of Bids and Legal Notices.

12. Open RFPs, CSPs, and RFQs are distributed to registered vendors in Ion Wave when released.
13. For bids under Education Code 44.031, a legal notice must be emailed to *Star Community Newspapers* (jcraghead@starlocalmedia.com), with a copy sent to the Director of Purchasing and the Business Office Secretary. Attach the confirmation to the bid in Smart Sheets until the



bid closes.

14. The legal notice must include bid specifications, requirements, closing date, and submission instructions. It will run for two consecutive weeks.
15. A help desk ticket is submitted to add the bid opportunity to the FISD Procurement web pages.
16. Vendors can modify their submissions via Ion Wave before the closing date, but changes are restricted after closure until awards are issued.

Bidding Process.

17. Suppliers must register on Ion Wave to submit bids electronically.
18. All inquiries regarding open solicitations should go through the Purchasing department, not directly to vendors.
19. The Buyer provides limited technical assistance and may hold a pre-bid conference, coordinating the agenda with FISD staff.
20. The Buyer collects questions from bidders and shares answers via Ion Wave.
21. During the bid opening:
 - Responses are reviewed for compliance with terms and completeness.
 - The Buyer communicates with bidders about any missing attachments.
 - The evaluation template is initiated, and preliminary information is added to the Board agenda.
22. The Buyer ensures all submissions, both electronic and hard copy, are managed properly.
23. Ion Wave prevents late submissions after the closing date. A help desk ticket is submitted to remove the bid from the Procurement web page post-closure.

Bid Evaluation.

24. Upon closing, the Buyer conducts a final review of vendor bids to ensure responsiveness:
 - Alignment with the scope of work
 - Completeness of responses
 - Inclusion of necessary documentation
25. The Buyer finalizes the download of documents from Ion Wave and uploads materials to the Google Drive to share.
26. The evaluation template is completed with scoring criteria, points to be awarded and names of entities to be evaluated.
27. The Buyer schedules a TEAMS call with new evaluators to confirm they've signed the NDA and Evaluator Guidelines, review scoring instructions, address additional scoring questions, and answer any evaluator inquiries. The meeting is optional for end users familiar with the current evaluation process and template when Buyer has no bid-specific information to share.



28. The Buyer emails vendor bids, including all review documents, the scoring template, and the “How to Score Responses” tip sheet to evaluators using the standard email template. The email includes:
 - Deadline for returning evaluations
 - Link to vendor responses downloaded from Ion Wave
 - Planned Board meeting date for vendor qualification
 - Instruction for evaluators to contact the Buyer if they cannot complete the review before the deadline
29. The Buyer notifies evaluation alternates of their status in case an evaluator cannot complete the review.
30. Purchasing will attempt to initiate evaluations with identified evaluators twice. If evaluators remain non-responsive, their reviews will not be submitted to the Board.
31. Evaluations typically involve multiple teams. Only evaluations completed by responsive evaluators will go to the Board.
32. The Purchasing Director will inform the evaluator and their appointing individual of any failure to engage in the evaluation process, with the CFO copied on the email.
33. The Buyer monitors evaluator progress, addresses questions, and compiles score sheets in the evaluation template as they are received.
34. The Buyer is responsible for sending clarification requests to vendors during the evaluation period.
35. Once scores are totaled, the Buyer shares them with the evaluation committee and relevant staff. Purchasing analyzes the scores and collaborates with campus and department staff on reference checks for high-scoring vendors, if necessary.
36. The Buyer asks if evaluators or project managers wish to schedule finalist interviews or presentations. If so, he or she will:
 - Collaborate on the number of finalists to invite
 - Determine interview/presentation format and length
 - Identify possible dates and locations, reserving rooms as needed
 - Decide which FISS staff should attend
 - Develop a scoring rubric with input from evaluators
37. The Buyer will also:
 - Combine finalist presentation scores with proposal scores
 - Send NDAs and evaluator guidelines to any additional staff scoring presentations: new evaluators sign an NDA before participating
 - Attach signed NDAs and other documents to the bid record in Smart Sheets until the bid closes.
 - Collect scoring rubrics from evaluators and attach them to the bid in Ion Wave, compiling



scores from finalist presentations and proposals

- Notify staff of the vendors proposed for Board recommendation.
- Moves all documentation from Smart Sheets to IonWave when the RFP closes (to include legal notice of advertisement from Star Local Media).

Best and Final Offers. The Buyer may request best and final offers or clarifications from bidders after finalists' interviews.

Qualification Recommendation. Preliminary Award. Frisco administration may preliminarily qualify a vendor pending successful contract negotiations. The selected vendor receives an email notification regarding the intent to negotiate.

Negotiation. Purchasing facilitates negotiations with the highest scoring vendor. If negotiations fail, the Buyer will notify the highest vendor and start discussions with the next highest scorer, continuing down the list until a decision is made or the bid is canceled.

Board Agenda Preparation. The Buyer updates the Board agenda on the Procurement I drive, creating a bid folder that includes the evaluation and Board Agenda Action Sheet.

Board Action Sheet Contents:

- Recommended vendors list
- Spending estimates (if applicable)
- Staff member representation
- Board meeting date
- Background information
- Qualification term dates

Agenda Submission. The Assistant to the Superintendent places the agenda item on the School Board's agenda, providing support materials for review.

Board Approval. The Board reviews and approves all bids/proposals, as recorded in the minutes.

Vendor Notification. The Buyer informs awarded vendors via a qualification notification in IonWave.

Post-Qualification Process. Award Notification. The day after the Board qualifies vendors, the Buyer logs into IonWave to finalize the qualification, notifying vendors of their status.

Form 1295 Request. If needed, the Buyer requests Form 1295 from the vendor, if needed. Review the 1295 requirements on the Texas Ethics Commission website to determine whether the vendor needs to submit a 1295. Instructions for filing a 1295 are on the website.

Vendor Team Notification. The Buyer emails the Vendor Team Senior Buyer with details about the qualified vendor, including the vendor name, number, awarded bids, and term dates.

Priority Processing. For priority vendors, the Buyer will seek approval from the Senior Buyer for expedited processing.



Qualification Extensions. Extension Terms. Vendor qualifications are typically one year, with optional extensions. If a contract does not meet district needs, the bidding process may be initiated at any time.

Tracking Extensions. The Buyer tracks bid +extensions and expirations using the FISD Bid Calendar in Smart Sheets and a monthly Cognos report.

Extension Correspondence. When a contract is up for extension, the Buyer contacts the relevant department to assess whether to extend, update, or cancel the contract.

Contract Manager Notification. Purchasing will notify the contract manager about the upcoming renewal and inquire if the bid continues to meet their needs.

Contract Extension Process.

- A. The contract manager or end user department must verify specifications and report any issues to the awarded vendor(s) before extension.
- B. Extensions will only be issued to previously awarded vendor(s) with satisfactory performance. Completion documentation will be sent to the requesting department upon request.
- C. Extension information will be added to the Board Agenda under "Information Items."
- D. If the District opts not to extend a qualification, the Buyer will email the vendor using the "non-renewal template" from the Purchasing Google Drive.

Post-Board Meeting.

38. The Buyer will email the Vendor Team to request updates in E-Finance, including address, phone, contact, PO email, A/R email, and contract expiration date. The extension will be "awarded" in Ion Wave.

Multiple Award Requests for Proposals (RFPs). FISD utilizes multiple qualification RFPs to purchase supplies and services for students and staff. These solicitations allow multiple vendors to be awarded contracts for similar products or services, such as catering. FISD ensures that MSA bids meet minimum competitive requirements. Purchases from MSA RFPs must meet FISD quote requirements.

Justification for Multiple Awards. The Director of Purchasing must create a memo explaining the need for multiple awards, stating that historical purchasing patterns are unpredictable. This memo confirms that multiple awards are necessary and appropriate.

Annual Review of Multiple Award Contracts. The Director of Purchasing conducts an annual review of contracts awarded through multiple qualification RFPs, including:

- Total expenditures for awarded vendors.
- Confirmation that conditions justifying multiple awards still exist.
- Evaluation of whether a single qualification may provide better value for FISD.

Examples of Multiple Award Procurements. Multiple qualification RFPs may be appropriate for:

- Administrative and instructional contracted services
- Professional development providers



- Catering and charter bus services
- Special event services (e.g., DJ services)
- School photography
- Specialty printing services

Catalog or Discount-From-List Procurements. These RFPs are used when multiple vendors offer similar goods, but specific needs may require different vendors. Examples include:

- Classroom instructional materials
- Fine arts supplies
- Health and vocational equipment

Protesting a Solicitation. Protest Information. Applicants receive information about protesting solicitations as part of the standard bid template. Protests must be submitted in writing to the responsible Buyer.

Forwarding Protests. The Buyer forwards protests to the Purchasing Director. For Child Nutrition bids, protests are sent to the Director of Child Nutrition, who will notify TDA.

Resolution Process. If the protest is valid or unresolved, it is forwarded to the CFO for further action.

Protesting a Qualification. Initial Review. The Purchasing Director meets with the protesting vendor to discuss the qualification details.

Formal Protest. If unresolved, the vendor may submit a formal protest within five business days of the public notice of qualification.

Notification Process. The written protest is sent to the responsible Buyer, who emails it to the relevant FISD staff based on the award value:

- Level 1: Up to \$499,999 – Purchasing Director
- Level 2: Above \$499,999 – CFO and Purchasing Director

Protest Contents. The protest must specify:

- Relevant statutory or regulatory provisions
- Description of alleged violations
- Relevant facts
- Issues to be resolved
- Supporting arguments

Procurement Delay. FISD will temporarily pause the procurement unless the CFO determines that proceeding is necessary.

Response Timeline. FISD will respond to the protest within 10 business days.

Appeal Process. The vendor may appeal the decision within five business days by sending a



written appeal to the FISD CFO and General Counsel.

Final Decision. FISD will inform the vendor of the decision. Appeals are not permitted.

Travel

Purchasing's Travel Desk manages travel for staff on school business. Staff should use the travel desk tile in Laserfiche for flight, hotel, conference registration, and car rentals. (see [FISD staff portal](#)).

Once a request is received, the Travel Specialist will finalize arrangements and send the requestor confirmation(s) and purchase orders. Approved employee travel expenses are reimbursed upon return only. **Attachment 2** outlines documents end users need for reimbursements. Purchasing's [Travel Work Vivo](#) page is a comprehensive guide to District travel.

Internal Controls

FISD uses requisitions change orders, (REQs) and purchase orders (POs) to ensure all purchases align with district needs, budget, and compliance requirements.

Requisitions. Use **Attachment 3** for standard requisition review (checklist). A purchase requisition notifies Purchasing that goods and/or services have been requested through eFin.

Requisition Processing Procedure.

1. The requestor at the campus or department enters a requisition. Guidelines and training are provided by Compliance.
2. Approval Workflow:
 - Requisitions are routed to the principal or department head in eFin for review.
 - They follow a specified approval workflow, including compliance checks for technology, furniture, or federal grants.
3. Finance reviews requisitions for budget and account code accuracy before forwarding to Purchasing. Incorrect items are returned for correction.
4. Purchasing Approval:
 - A. The Buyer logs into eFin, selects "L—Approved at Lower Level," and checks the "required" box to view the requisition queue.
 - B. The Buyer opens the requisition to verify purchase order type and requested goods/services.

Alternative Payments (Alt Pays). Alt Pays are issued when an end user needs a check before an event or if the purchase does not need to be received in eFin (intangible goods). Examples: Field trips (initial deposits), refunds, employee reimbursements, memberships

Approving Alt Pays.

1. Log into eFinance. Navigate to **Purchasing > Requisition Processing > Approve/Deny Requisitions.
2. Select Approval Criteria. Choose 'L-Approve at Lower Level' and input "2*" in the Approval Group box.



3. Review Alt Pay requisitions using the checklist in **Attachment 4**.
4. Approval Actions. Click “Approve” if the alt pay information is correct to finalize. If corrections are needed, use the “Needs Correction” button to provide brief notes. Use the standard needs correction emails to return alt pays.
5. Print Purchase Orders. Navigate to ****Purchasing > Purchase Order Processing > Purchase Orders****, select “Complete” status, and print.

Not-to-Exceed Requisitions. NTE requisitions are one-time orders for goods/services not exceeding a specified amount, usually \$500 or less. The requisition must include "NTE" in the comments.

Requisitions for Blanket POs. BPOs are ongoing purchase orders with a fixed amount for the same vendor, typically for contracted services at a set hourly rate. Change orders cannot be requested for BPOs. If the requisition is for a campus BPO, approval from the Purchasing Director is needed. For department requests, ensure appropriateness for a BPO. If the request is not reasonable, deny it.

Corrections and Cancellations: Standard and Alt Pay Requisitions. Needs Correction.
Always use the email templates to return requisitions to end users.

Emergency Requests. Needed for the safety and security of students, staff and facilities. Ask the end user to have his or her principal contact the Purchasing Director to expedite requisitions. Notify Accounts Payable for special processing if a check is needed outside normal schedules.

Cancellation. To cancel an approved PO, email Accounts Payable with the PO number and reason. For ones unapproved deny the approval.

Purchase Orders

Purchase order review is a second review of the information and details reviewed by the Requisitions Team.

1. Log into eFinance. Navigate to ****Purchasing > Purchase Order Processing > Approve/Deny Purchase Orders**.
2. Select Approval Criteria. Choose ‘L-Approve at Lower Level’.
3. Review Purchase Orders using the checklist in **Attachment 3**.
4. Approval Actions. Click “Approve” if the purchase order information is correct to finalize. If a purchase order does not meet approval criteria, select “Deny,” and enter the reason for denial in the dialog box. The Purchase Order is denied, and a notification is sent to the user.
5. Print Purchase Orders.
 - a. Alt. Pays will be printed first - Navigate to ****Purchasing > Purchase Order Processing > Purchase Orders****, input 2* in the Approval Group field, select Complete status, search, and print. *Uncheck the box “email document to vendor.”
 - b. Once Alt. Pays have printed, repeat the process to print traditional Purchase



Orders. Navigate to ****Purchasing > Purchase Order Processing > Purchase Orders****, select “search,” print purchase orders.

Change Orders. Change orders correct issued POs (quantity, dollar amount, or budget/account code changes). They cannot be processed for BPOs, except for specific departments. To approve a change order:

1. Log into eFinance and select “Approve/Deny Change Orders.”
2. Choose approval criteria and check “Required.” Click OK to view waiting change orders.
3. Open the change order and check the related PO for requested changes.
4. If it’s a BPO from a non-exception department, deny the change and advise on submitting a new BPO.
5. Ensure the end users attach a brief explanation for the change. Contact the end user if it is not attached.
6. After review, click “Approve” and confirm changes. Print the change orders from the change order listing screen.

Change Order Printing Process. *Print Change Orders.* In the print dialog, uncheck "Email document to vendor" and click "OK". Respond to the pop-up boxes by clicking "Yes" and "OK" until prompted with "Did the change order print correctly?" Click "Yes".

Reprint Purchase Order.

- Navigate back twice in the menu.
- Select: ****Purchasing > Entry & Processing > Purchase Order Processing > Purchase Orders****.
- Enter the purchase order number and click "Find".
- Click "Print Purchase Orders".
- In the print dialog, check "Reprint purchase orders", uncheck "Email document to vendor", and click "OK".
- Click "Yes" and "OK" through the pop-up prompts.

Credit and Store Cards

Credit Card. FISD does not have a p-card program. Campuses or departments may request to use the Business Services credit card, primarily for urgent purchases or when a vendor only accepts credit cards. Exceptions require approval from the Purchasing Director or CFO. A District credit card purchase form is available in Laserfiche.

Process for Credit Card Purchases.

1. **Submit Request.** The requesting department submits a District Credit Card Purchase Request.
2. **Approval Workflow.** The approval workflow includes requesting department → Purchasing Director → CFO assistant. Notifications go to Accounting, Purchasing, and CFO.
3. Purchasing verifies vendor status in eFinance, checking:
 - Current vendor status
 - Competitive purchasing
 - guidelines
 - Aggregate expenditures, which must be under \$50K.



4. [Vendor Setup](#). If necessary, the Buyer directs the requestor to submit a new vendor packet to add the vendor to eFinance.
5. [Decision](#). After review Purchasing approves or denies the request.
6. [Final Approval](#). If approved the purchase is made by CFO's office.
7. [Record Keeping](#). All transactions are recorded in Laserfiche and captured in the GL.

A non-compliant purchase approval form must be submitted for credit card purchases not following procedures.

Store Cards Management.

Annual Inventory and Training.

[Collection](#). The CFO's office manages annual store card collection and inventory.

[Compliance Training](#). Compliance trains secretaries on proper card usage. Training is mandatory. Principals must also complete the training annually.

[Distribution](#). Store cards are distributed based on needs.

[New Vendor and Store Card Setup](#). Purchasing orders new vendor store cards and logs card numbers. New store cards follow the annual inventory process.

[Lost or Stolen Store Cards](#). End users must report lost or stolen cards to the CFO's Office, which informs Purchasing to deactivate or replace cards.

[Employee Departures](#). Principals are responsible for collecting all store cards when employees leave Fisd.

[Additional Store Cards Checkout](#). (Hobby Lobby, Kroger, United Supermarket)

- The CFO's Executive Assistant manages checkout of additional cards.
- Staff must have a copy of the PO when checking out a store card and return it within 24 hours.

Vendor Management in e-Fin

Vendor contract information is manually entered in e-Fin to expedite approval and document purchase method. When a new contract is awarded or a current one renewed, we must update several screens in eFinance.

Updating Contract Information (Screen 5000).

1. From the eFinance home page, staff clicks on ****Vendor List**** to access the Search Criteria screen.
2. Staff locates the vendor by entering the vendor number or searching by name or keyword in the ****Vendor Name**** or ****Search Name**** fields, using asterisks (*) around the search terms (e.g., *Costumes by Dusty*).
3. Staff selects the desired vendor (search results may include several) and clicks on



****Defined Windows**** at the top.

- Staff highlights ****5000 Contract Information**** and clicks the green ****OK**** button at the top. Screen 5000 follows this format:

Locating Contract Information for Sole Source.

1. Ensure the sole source vendor has a current signed and notarized Sole Source Affidavit attached the vendor file in eFinance:
2. Save the sole source file on your computer.
3. Click the paperclip icon and attach the document.
4. Enter the expiration date in screens 5000 and 5002 (sole source agreements expire one year from update).

Locating Contract Information for RFPs from Other Districts.

 - RFP / Contract (includes details like qualification date and expiration).
 - Supplier Response (provides contact info, discounts, and PO email).

Divestment Look-up Procedure

The Texas Comptroller provides divestment lists under TGC 808.051, TGC 2252.153, and TGC 2270.0209 for compliance with contracting requirements. Public procurement professionals must verify that new vendors are not on these lists before completing purchases and regularly check existing vendors.

New Vendor Verification. After setting up a new vendor in eFinance, staff visits the [Comptroller's divestment lists](#) to verify the vendor's status.

1. If the vendor is not listed, enter "YES" in the D&D Lookup field on screens 5002-5006 and sets an expiration date one year from the verification date.
2. If the vendor is on a divestment list, inform them they are ineligible to sell to FISC and places their eFinance vendor file on "BIDDING" hold.

Existing Vendor Verification. Throughout the year, a list of vendors requiring divestment checks is reviewed.

1. As checks are completed, the divestment expiration date is updated.
2. If an existing vendor is found on a divestment list, the Buyer notifies them of their ineligibility and places their eFin
