

FISD+ Application Instructions for students not enrolled in FISD

If your student is a current FISD enrolled student, please use this [current FISD student application form](#) for FISD+ program.

Important Information about program on form

This program application is for individuals who currently live in Frisco ISD but do not attend a Frisco ISD school. If you currently attend an FISD school you must apply through the Guardian Gateway. Please note that if you do not include all required documents your application will not be considered. If your child does not meet the required standards as set by [Senate Bill 15](#) there is another opportunity to apply in late summer 2022 if your child meets the guidelines for the 2022 school year.

- Academic success demonstrated on the final report card or transcript for the **current** school year.
- On grade level with graduating cohort.
- Less than 10 unexcused absences in the **current** school year.
- We suggest you have passed the **previous** school year on-level STAAR/EOC exams.
- If you have not taken STAAR/EOC you must take and pass the state exams.

For students currently in eighth grade: Final eligibility will include passing the **current** school year STAAR exams, passing grades in all classes and attendance records that meet minimum requirements.

For students currently in ninth through eleventh grade: Final eligibility will include students having passed the requisite **current** school year EOCs to date, passing grades in all classes, attendance records that meet minimum requirements and on track to graduate in four years.


